Reference is invited to the MHA OM dated 19th September, 2024 (copy enclosed) which forwards the nomination of Shri Sanjay A Lathkar, IPS (JH: 95) for the post of Inspector General (Security) (JS Level) in the Department of Atomic Energy.

- 2. In connection with this, it is to inform that the post of Inspector General (Security) in the Department has been lying vacant since 01.9.2022. Since then, this Department has been continuously sending reminders to the MHA/ DoPT for filling the position.
- 3. It has also been emphasized that, given the sensitivity of nuclear installations across the country, the post of Inspector General (Security) cannot remain vacant for extended periods. In this context, to fill the post of IG (S), DAE, the MHA has invited applications from willing and suitable officers multiple times. However, due to the non-receipt of nomination from officers, the position remains vacant.
- 4. Following persistent efforts, it is learnt from the above MHA OM dated 19.9.2024 that one nomination, from Shri Sanjay A Lathkar, IPS (JH: 95), who is currently serving as ADG in Cadre in Level-15, has been received by the MHA.
- 5. In this regard, it is requested that the post of Inspector General (Security), DAE, currently in Level-14, be temporarily upgraded to Level-15 on personal basis for the duration that Shri Sanjay A Lathkar, IPS (JH: 95), holds the position of Inspector General (Security) in the Department of Atomic Energy.
- 6. Since, Hon'ble Prime Minister is the Minister-in-charge of this Department, the proposal would be seen by the Hon'ble Prime Minister when the same comes before the Appointments Committee of the Cabinet (ACC). It is therefore, requested that the proposal may please be placed before the ACC.
