NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Sikkim hereby makes the following rules further to amend the Sikkim State Para-Medical Service Rules, 1998, namely:-

1. (1) These rules may be called the Sikkim State Para-Medical Service (Amendment) Rules, 2020.
- (2) They shall come into force at once.
2. In the Sikkim State Para-Medical Service Rules, 1998, in Schedule-II,-
  - (i) Under the heading "Nutrition Wing", against Sl.No. 3, under the column "Eligibility condition", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the post of Deputy Director (Nutrition) for at least 02 (two) years on substantive capacity";
  - (ii) Under the heading "Health Education Wing" against Sl.No. 3, under the column "Eligibility condition", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the post of Deputy Director (Health Education/ Mass Media/ School Health) for at least 02 (two) years on substantive capacity."
  - (iii) Under the heading "Central Health Stores Organization/ Family Welfare" against Sl.No. 3, under the column "Eligibility condition", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the post of Senior Medical Officer (Central Health Stores Organization/ Family Welfare) for at least 02 (two) years on substantive capacity";
  - (iv) Under the heading "STNM Hospital/ District Hospital (Dietetics)" against Sl.No. 3, under the column "Eligibility condition", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the post of Senior Dietician for at least 02 (two) years on substantive capacity";
  - (v) Under the heading "STNM Hospital/ District Hospital" against Sl.No. 3, under the column "Eligibility condition", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the post of Deputy Director (Sanitation) for at least 02 (two) years on substantive capacity";

(vi) Under the heading "H. STNM/DISTRICT HOSPITAL" against Sl.No. 3, under the column "Eligibility condition", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the post of Senior Physiotherapist for at least 02 (two) years on substantive capacity";

(vii) Under the heading "PREVENTATION OF FOOD ADULTERATION CELL" against Sl.No. 3, under the column "Eligibility condition", for the clause (c), the following clause shall be substituted, namely:-

"(c) he/she should have worked in the post of Senior Food Inspector for at least 02 (two) years on substantive capacity".
